The notice requirements of the Open Public Meetings Law have been satisfied as notice was sent to two newspapers and posted on the Borough Hall bulletin board on January 20, 2014.

Warren Waters spoke concerning Riverfront Development. Mr. Walters discussed redevelopment of the Sifford Pontiac site as well as the Hess property. He explained the need for correcting environmental issues and requested support from Bogota Council on those matters. He is hoping for a resolution to be passed in the near future to allow him to begin the work.

Citizen Remarks:

Dan Creange of 132 Wykoff Avenue, Wykoff, NJ spoke about the Regina Tasca Case. He asked the Council to reconsider their position concerning Tasca.

Bill Brennan of 14 Iowa Road, Wayne, NJ.also spoke about Regina Tasca and his support of her.

George Silos of 385 Larch Avenue spoke in support of Regina Tasca as well.

David Rushfield of 459 River Road asked about redoing sidewalks, curbs, and streets on West Grove Street. The Administrator and the Mayor assured Mr. Rushfield that the work would be done there soon.
